STANDARD LICENSE

MASTER RECORDING

This license is a non-exclusive & non-transferable license to record vocal synchronization to the composition partly or in its entirety and substantially in its original form ("master recording").

DISTRIBUTION

Sell up to **2,500** copies worldwide for a duration of **3** years from the date of purchase. The amount of non-profit and non-commercial downloads or streams is unlimited. In the event that an exclusive license is sold by Licensor to the Composition, the terms of this agreement shall be upheld.

PAYMENT & DELIVERY

All payments are processed via PayPal or credit card. Once checkout has completed, you will immediately receive an email containing download links and license agreement. The standard license contains a high quality **Mp3 file** and will be delivered with **all watermarks removed** (except 1 intro tag).

SYNCHRONIZATION & STREAMING

The licensor hereby grants limited synchronization rights for **1 music video** streamed online (YouTube, Vimeo, etc..) for up to **50.000 non-monetized** video streams on all total sites. A separate synchronization license will need to be purchased for distribution of video to Television, Film or Video game. This license allows up to **50.000 monetized** audio streams to sites like (Spotify, iTunes etc.), but not eligible for monetization on YouTube. It also **does not** grant any kind of radio broadcasting rights.

PUBLISHING & ROYALTIES

The Licensee is entitled to keep 100% of all income that is generated from sales of the Master Recording on digital retailers (such as iTunes), through physical sales (such as Compact Disks) and on online streaming services (such as Spotify).
